5. The bidders shall submit their bid before **2081/09/07 (2024 DEC 22) 12:00 hrs.** The bids will be opened in the presence of Bidders' representatives who choose to attend at **2081/09/07 (2024 DEC 22) 13:00 hrs.** at the office of **Kanepokhari Rural Municipality, Bayarban, Morang.**

6. Bid security must be valid for a period of **90 days as stated below** for after bid opening and must be accompanied by a bid amounting to a minimum of **as specified below** which shall be valid for 30 days beyond the validity period **(i.e., 120 days) of the bid after deadline of Bid submission date.**

7. If the last date of Pre-Bid meeting and Bid Opening Day falls on a government holiday, then the next working day shall be considered as the last date. In such case the validity period of the bid security shall remain the same as specified for the original last date of bid submission.

8. Bidders may submit modification or withdrawal prior to the deadline of bid submission. Once a Bid is withdrawn, bidder will not be able to submit another bid response for the same bid.
